Review of Safety Information by Owners of Non-EASA aircraft (commonly referred to as Annex 2)

This Information Notice contains information that is for guidance and/or awareness.

Applicability:	
Aerodromes:	Not Primarily Affected.
Air Traffic:	Not Primarily Affected.
Airspace:	Not Primarily Affected.
Airworthiness:	Maintenance Organisations in the support of non-EASA aircraft.
Flight Operations:	All General Aviation Pilots.
Licensed/Unlicensed Personnel:	Engineers involved in the maintenance support of non-EASA aircraft.

1. Introduction

- 1.1 This Information Notice is to raise awareness of the need for Owners/Operators and Maintainers of non-EASA aircraft to assess Safety Information relating to, but not limited to, Engines, Equipment, Propellers and Components that may be generated by other Airworthiness Authorities. The information may be originally intended for EASA type aircraft and therefore may be overlooked. However, the subject may refer to certain types of engines, equipment or propellers that are installed on non-EASA aircraft.

2. Scope

- 2.1 Owners/Operators and Maintainers should ensure they are able to receive/access and assess Safety Information generated by Airworthiness Authorities in the form of, but not limited to, the following:

EASA SIB	Safety Information Bulletin
EASA CI	Certification Information
FAA SAIB	Special Airworthiness Information Bulletin
FAA UPN	Unapproved Parts Notification
TC	Service Difficulty Advisories
