CAA Information Bulletin on EASA Developments – 26 January to 3 March 2016

1 Introduction

1.1 This Information Notice provides highlights of EASA developments and CAA activities covering the period 26 January 2016 to 3 March 2016.

2 EASA Committee

- 2.1 The EASA Committee met on 17-18 February 2016. The agenda covered the following substantive items:
 - i) Update on on-going Commission adoption procedures *Information by the Commission*
 - Regulation 1178/2011 Flight Crew Licensing, amendment delaying the implementation of the provisions for third country pilots licences. The Commission advised that the amendment is moving through the Council and Parliament co-decision process and should be in place by 8 April 2016. The change is intended to allow additional time to conclude a change to the EU-US bilateral aviation safety agreement to include new arrangements for Flight Crew Licensing.



- ii) Draft Commission Regulation amending Commission Regulation (EU) No. 965/2012 as regards operational approval of performance-based navigation, certification and oversight of data services providers and helicopter offshore operations, and correcting that Regulation *Discussion and possible vote*
 - Following changes made to entry into force provisions to address Member States' concerns arising from the last EASA Committee meeting, Member States voted on the revised proposal. A positive vote was made with only one State voting against the proposal.
- iii) Draft Commission Regulation amending Commission Regulation (EU) No. 1321/2014 as regards the introduction of B2L and L Part-66 licences, the modification of the acceptance procedure of components from external suppliers and the modification of the Part-147 organisation privileges *Discussion and possible vote*,
 - The Member States present voted unanimously for the proposal.
- iv) Draft Commission Regulation amending Commission Regulation (EU) No. 452/2014 as regards the technical requirements and administrative procedures relating to air operations of Third Country Operators *Discussion and possible vote*
 - The Member States present voted unanimously for the proposal.
- v) EASA Opinion No. 01/2016 on revision of the European operational rules for balloons Orientation discussion
 - The Commission briefed Member States on their proposals for a specific regulation addressing the Balloon Operations. The Members States considered the proposals to be an appropriate and proportionate response for the ballooning Community.
- vi) EASA Opinion No. 06/2015 on commercial air transport aeroplane operations at night or in IMC using single-engine turbine aeroplanes (CAT SET/IMC) *Orientation discussion*
 - The Commission briefed the Member States on their proposals. The response was broadly positive with some States asking for some more detailed information before committing to all aspects of the proposal.
- vii) Drones: EASA technical opinion of 18 December 2015 on the introduction of a regulatory framework for the operation of unmanned aircraft and further steps *Discussion*
 - EASA presented their proposed framework for the operation of drones within the Community. The presentation was based on the content of A-NPA-2015-10 and the comments received through the A-NPA consultation process. The Member States welcomed the proposals and looked forward to the Commission synchronising the development of this proposal with the changes being proposed to the EASA Basic Regulation. This would enable the establishment of a harmonised European regulatory framework to be brought into effect shortly after the Basic Regulation is amended.
- viii) EU-ICAO Synchronisation: update Information by the Commission
 - EASA and the Commission are keen to ensure that Member States' responses to ICAO State letters are well coordinated. They explained how they intend to improve their communication protocols to ensure that there is sufficient time for a common European position to be agreed before Member States respond to State Letters. EASA also briefed on their recent updates to the ICAO Annex compliance checklists produced by the Agency for most annexes, which are intended to help Member States compile their detailed compliance submissions to ICAO.



ix) Any Other Business (AOB)

Update on BASAs (Bilateral Aviation Safety Agreements) - Information by the Commission

EASA briefed on proposals from the Commission to start discussions with China and Japan on new bilateral aviation safety agreements. The discussions are intended to be limited to aircraft certification and maintenance at this stage.

EU-US

It is expected that the Technical Implementation Procedures for aircraft, engine and equipment certification will be revised by Bilateral Oversight Board decision during February 2016. This will allow reciprocal acceptance of TSO and ETSO items without validation by the other party; and the validation of basic STCs through a new nontechnical review process. These changes are intended to reduce the burden and costs to organisations, the FAA and EASA.

EU-Canada Agreement

There is an intention to create a new annex to the agreement addressing Flight Crew Licensing. Discussions are at an early stage.

EU- Brazil Agreement

The EU and Brazilian authorities are pleased with progress made on the initial application of the new safety agreement. The first oversight board meeting will be held soon. This may result in changes to the Maintenance Annex Guidance being agreed that will address minor issues identified during the initial implementation of the agreement.

3 Other Rulemaking Topics

3.1 Carriage of special categories of passengers

> EASA published Executive Director (ED) Decision 2016/004/R on Carriage of special categories of passengers amending AMC and GM to Commission Regulation (EU) No. 965/2012, on 22 January 2016.
