1. SCOPE

1.1 <u>Purpose</u>. The purpose of this Standard is to provide uniform requirements for packing and marking of petroleum and related products.

1.2 Application.

1.2.1 <u>Centrally procured items</u>. The level of protection as well as any special marking requirements will be incorporated in purchasing documents.

1.2.2 Locally procured items. This Standard is not mandatory for items locally procured for immediate use.

1.3 Options. Where options are indicated concerning methods of packaging or designation of the method is not specified in the contract or order, the selection shall be at the option of the contractor.

2. REFERENCE DOCUMENTS

2.1 The following documents of the issues in effect on the date of invitation for bids or request for proposal form a part of this standard to the extent specified herein.

3. DEFINITIONS

3.1 <u>Commercial packaging</u>. The methods and materials employed by the supplier to satisfy the requirements of the commercial distribution system.

3.2 Exterior pack. A container, bundle, or assembly which is sufficient by reason of material, design and construction to protect material during shipment and storage. This can be the unit pack or a container with any combination of unit or intermediate packs.

3.3 <u>Intermediate pack</u>. A wrap or box which contains two or more identical unit packs.

3.4 Levels of protection. The degree of preservation or packing required to prevent deterioration or damage to supplies and equipment due to the hazards to which they may be subjected during shipment and storage.

3.5 <u>Marking</u>. Application of numbers, letters, labels, tags, symbols or colors for handling or identification during shipment and storage.

3.6 <u>Shelf-life item</u>. An item of supply possessing deteriorative or unstable characteristics to the degree that a storage time period must be assigned to assure that it will perform satisfactorily in service. There are two types of shelf-life items.

3.6.1 <u>Type I Shelf-life item</u>. An item of supply which is determined through an evaluation of technical test data and/or actual experience, to be an item with a definite nonextendible period of shelf life. THIS DOCUMENT PROVIDED BY THE ABBOTT AEROSPACE TECHNICAL LIBRARY ABBOTTAEROSPACE.COM

3.6.2 <u>Type II Shelf-life item</u>. An item of supply with an assigned storage time period which may be extended after the completion of prescribed inspection and/or restorative aciton.

3.7 Unit pack. The first tie, wrap or container applied to a single item or a quantity thereof, or to a group of items of a single stock number, preserved or unpreserved, which constitutes a complete identifiable pack. For petroleum products, the unit pack is a can, drum, pail, or the pack described in the requirements, section 4 and 5.

4. GENERAL REQUIREMENTS

4.1 Unit containers. Unit containers for packaging petroleum and related products shall conform to the requirements for level B or C, or commercial as specified in Table I. Closures and seals for unit containers shall be as specified in Table I.

4.2 <u>Coating of metal containers</u>. Metal containers shall be coated as specified in Table I and 5.9.

4.3 <u>Packing</u>. Petroleum and related products in unit containers specified in Table I shall be packed level B or C, or commercial as specified in 5.1 through 5.6. Certain speciality products shall be packed as specified in 5.7.

4.4 <u>Marking</u>. Packed petroleum and related products will be marked as specified in 5.10.

4.5 <u>Palletization</u>. When specified, packed petroleum and related products will be palletized in accordance with 5.8.

4.6 <u>DOT Regulations</u>. All petroleum and related products regulated by the Department of Transportation shall be packaged in containers conforming to 49 CFR. Additionally, when specified, petroleum and related products shall be packaged in containers meeting the 15 PSI internal air gauge pressure leakage test requirements.

3. DETAILED REQUIREMENTS

#### 5.1 Packing products in composite cans.

5.1.1 Unit packing. Petroleum shall be furnished in composite cans conforming to the requirements in Table I for level B or C, or commercial as specified in the contract or order.

5.1.2 Exterior packing. Filled and closed composite cans shall be packed level B or C, or commercial as specified in the contract or order.

5.1.2.1 Level B. Filled and closed composite cans, in the quantity and arrangement specified in Table II, shall be packed in V3c, V3s, W5c, or W5s style RSC fiberboard boxes constructed and closed in accordance with PPP-B-636. Boxes shall be top loading or end loading.

5.1.2.2 <u>Level C</u>. Filled and closed composite cans, in the quantity and arrangement specified in Table II, shall be packed in domestic, style RSC fiberboard boxes constructed and closed in accordance with PPP-B-636. Boxes shall be top loading or end loading.

5.1.2.3 <u>Commercial</u>. Filled and closed cans shall be packed in a manner that will afford adequate protection against damage during direct shipment from the supply source to the first receiving activity. The shipping containers shall conform to the Uniform Freight Classification Rules or other carrier regulations applicable to the mode of transportation.

### 5.2 Packing products in metal cans.

5.2.1 Unit packing. Petroleum and related products shall be furnished in metal cans conforming to the requirements in Table I for level B or C, or commercial as specified in the contract or order.

5.2.2 <u>Intermediate packing</u>. Filled and closed metal cans of less than 1-pint capacity shall be intermediately packed in accordance with commercial practice.

5.2.3 Exterior packing. Filled and closed cans shall be packed level B or C, or commercial as specified in the contract or order.

#### 5.2.3.1 Level B.

5.2.3.1.1 Intermediate packs of filled cans of less than 1-pint capacity. Intermediate packs in the quantity and arrangement specified in Table II, shall be packed in V3s, V3c, W5s, or W5c style RSC fiberboard boxes constructed and closed in accordance with PPP-B-636. Boxes may be end loading or top loading.

5.2.3.1.2 Filled cans 1-pint capacity and over. Filled and closed cans of 1-pint capacity and over, in the quantity and arrangement specified in Table II, shall be packed in snug fitting V3s, V3c, W5s, or W5c style RSC fiberboard boxes constructed and closed in accordance with PPP-B-636. Boxes may be end loading or top loading. Cans with protruding closures shall be protected with cell spacers or buffer pads, formed from scored sheets of fiberboard or from polystyrene cusjioning materials or full height, snug fitting, half-slotted style, interlocking fiberboard partitions. The design number and arrangement of the pads shall prevent movement and provide clearance.



## 5.2.3.2 Level C.

5.2.3.2.1 Intermediate packs of cans less than 1-pint capacity. Intermediate packs in the quantity and arrangement specified in Table II shall be packed in snug-fitting domestic grade, style RSC fiberboard boxes constructed and closed in accordance with PPP-B-636. Boxes may be top loading or end loading.

5.2.3.2.2 Filled cans 1-pint capacity and over. Filled cans of 1-pint capacity and over shall be packed and cushioned as specified in 5.2.3.1.2 except that the fiberboard boxes shall be domestic grade.

5.2.3.3 <u>Commercial</u>. Filled and closed cans shall be packed in a manner that will afford adequate protection against damage during direct shipment from the supply source to the first receiving activity. The shipping containers shall conform to the Uniform Freight Classification Rules or other carrier regulations applicable to the mode of transportation.

5.3 <u>Packing Standard Grease Cartridges (14-ounce nominal contents</u> for Cartridge-type Grease Guns).

5.3.1 Unit packing. Grease shall be furnished in grease cartridges conforming to the requirements in Table I for level B or C, or commercial as specified in the contract or order.

5.3.2 <u>Intermediate packing</u>. Filled cartridges shall be intermediately packed in accordance with commercial practice.

5.3.3 Exterior packing. Exterior packing shall be level B or C, or commercial as specified in the contract or order.

5.3.3.1 Level B. Not more than sixty filled grease cartridges, intermediately packed as specified in 5.3.2, shall be packed in V3c, V3s, W5c, W5s, W6c, or W6s, style RSC fiberboard boxes constructed and closed in accordance with PPP-B-636. Boxes may be top loading or end loading.

5.3.3.2 Level C. Not more than sixty filled grease cartridges, intermediately packed as specified in 5.3.2 shall be packed in domestic grade, style RSC fiberboard boxes constructed and closed in accordance with PPP-B-636.

5.3.3.3 <u>Commercial</u>. Filled cartridges shall be packed in a manner that will afford adequate protection against damage during direct shipment from the supply source to the first receiving activity. The shipping containers shall conform to the Uniform Freight Classification Rules or other carrier regulations applicable to the mode of transportation.

5.4 Packing products in drums. Petroleum and related products shall be furnished in drums conforming to the requirements in Table I for level B or C, or commercial as specified in the contract or order. Drums require no further packing.

5.5 Packing products in pails. Petroleum and related products shall be furnished in pails conforming to the requirements in Table I for level B or C, or commercial as specified in the contract or order. Pails require no futher packing.

## 5.6 Packing products in bottles, jars and collapsible tubes.

5.6.1 Unit packing. Petroleum and related products shall be furnished in bottles, jars, or collapsible tubes conforming to the requirements in Table I for level B or C, or commercial as specified in the contract or order.

5.6.2 Intermediate packing. Filled bottles, jars, or collaspible tubes of less than one pound capacity shall be intermediately packed in accordance with commercial practice.

5.6.3 Exterior packing. Exterior packing shall be level B or C, or commercial as specified in the contract or order.

5.6.3.1 Level B. Unit and intermediate packs in quantities and arrangement specified in Table III shall be packed in V3c, V3s, W5s, W5c, W6s, or W6c fiberboard boxes constructed and closed in accordance with PPP-B-636. Boxes may be top loading or end loading. For one-pound unit containers and larger, full-height partitions with full-size top and bottom pads shall be used.

5.6.3.2 Level C. Unit and intermediate packs shall be packed as specified in 5.6.3.1 except that domestic grade, style RSC boxes constructed and closed in accordance with PPP-B-636 shall be used.

5.6.3.3 <u>Commercial</u>. Filled bottles, jars or collapsible tubes shall be packed in a manner that will afford adequate protection against damage during direct shipment from the supply source to the first receiving activity. The shipping containers shall conform to the Uniform Freight Classification Rules or the carrier rules and regulations applicable to the mode of transportation.

5.7 Packing of Speciality Products.

5.7.1 Stick form grease.

5.7.1.1 Unit packing. Stick form grease shall be unit packed in accordance with commercial practice.

5.7.1.2 Exterior packing. Stick form grease shall be packed level B or C, or commercial as specified in the contract or order.

5.7.1.2.1 Level B. Stick form grease unit packed as specified in 5.7.1.1, shall be packed in V3c, V3s, W5c, W5s, W6c, or W6s fiberboard boxes constructed and closed in accordance with PPP-B-636. The weight shall not exceed the weight limit of PPP-B-636.

5.7.1.2.2 Level C. Stick form grease, unit packed as specified in 5.7.1.1, shall be packed in domestic fiberboard boxes constructed and closed in accordance with PPP-B-636. The weight shall not exceed the weight limit of PPP-B-636.

5.7.1.2.3 Commercial. Stick form grease shall be packed in a manner that will provide adequate protection against damage during direct shipment from the supply source to the first receiving activity. Shipping containers shall conform to the Uniform Freight Classification Rules or carrier rules applicable to the mode of transportation.

5.7.2 Wax.

5.7.2.1 Unit packing.

5.7.2.1.1 One-pound wax cakes. Wax may be furnished in single 1-pound or four 1/4 pound cakes. Single one-pound cakes or four 1/4 pound cakes shall be wrapped in wax paper or unit packed in plastic bags, folding or set up boxes.

5.7.2.2 <u>Exterior packing</u>. Wax shall be packed level B or C, or commercial as specified.

5.7.2.2.1 Level B.

5.7.2.2.1.1 <u>One-pound wax cakes</u>. Twenty (20) one-pound cakes or 80 1/4 pound cakes, unit packed as specified in 5.7.2.1, shall be packed in V3s, V3c, W5c, W5s, W6c, or W6s fiberboard boxes constructed and closed in accordance with PPP-B-636.

5.7.2.2.1.2 Ten and eleven-pound wax slabs. Five or six 10 or 11-pound slabs shall be packed in V3s, V3c, W5c, or W5s fiberboard boxes constructed and closed in accordance with PPP-B-636.

5.7.2.2.1.3 <u>Solid Wax</u>. Solid wax shall be packed in fiber drums conforming to Grade C, Type II of PPP-D-723. Net contents of hot filled drums shall be 370 plus or minus 30 lbs.

5.7.2.2.2 Level C.

5.7.2.2.2.1 <u>One-pound wax cakes</u>. Twenty (20) one-pound cakes or 80 1/4 pound cakes, unit packed as specified in 5.7.2.1, shall be packed in domestic fiberboard boxes constructed and closed in accordance with PPP-B-636.

5.7.2.2.2.2 Ten and eleven-pound wax slabs. Five or six 10 or 11-pound slabs shall be packed in domestic fiberboard boxes constructed and closed in accordance with PPP-B-636.

5.7.2.2.3 <u>Solid wax</u>. Solid wax shall be packed in fiber drums conforming to grade C, Type I of PPP-D-723. Net contents of hot-filled drums shall be 370 plus or minus 30 lbs.

5.7.2.2.3 <u>Commercial</u>. Wax shall be packed in a manner that will afford adequate protection against damage during direct shipment from the supply source to the first receiving activity. The shipping containers shall conform to the Uniform Freight Classification Rules or the carrier rules and regulations applicable to the mode of transportation.

5.8 Palletization. When specified, packed petroleum and related products shall be palletized in accordance with MIL-STD-147. Marking of palletized loads shall be in accordance with 5.10.4.5. Unless otherwise specified, double wing pallets shall be used.

## 5.9 Exterior Color Coating of Metal Containers.

5.9.1 General. Exterior coatings on metal containers shall be OLIVE DRAB, approximating No. 24064 or 24087 of Federal Standard 595, for all containers except as specified in 5.9.2 through 5.9.5. Certain container areas shall be uncoated as specified in 5.9.2 through 5.9.5. Type I cans requiring uncoated top and bottom lids shall have a 1/4 inch uncoated margin on both ends of 8-ounce can bodies, a 1/2 inch uncoated margin on both ends of 1-quart can bodies and 3/4 inch uncoated margin on both ends of 1-quart striping on side seams is not required. Exterior coatings are not required on friction rings, on tops and bottoms of 4-ounce capacity or less cans, or on collapsible tubes. When level C or commercial practice is specified, exterior coating of metal containers shall conform to above referenced specification or to the supplier's commercial practice, except that solid RED, YELLOW or GREEN coatings shall be used only as specified in 5.9.2 through 5.9.5.

### 5.9.2 Hydraulic Fluids.

5.9.2.1 <u>Color</u>. For RED or YELLOW colors the enamel shall conform to Specification MIL-E-19603 and the primer to Specification MIL-P-19602. Colors for containers of other hydraulic fluids shall be as specified in 5.9.1. Color number shall conform to those listed in Federal Standard 595.

a. <u>MIL-H-5606</u>. Hydraulic Fluid, Petroleum Base, Aircraft Missile and Ordnance. Containers of one gallon or less and 10-gallon drums shall be coated RED, a color approximating Color No. 11105 or 21105. Except for 10-gallon drums, containers larger than one-gallon shall be coated OLIVE DRAB, approximating Color No. 24064 or 24087. Exterior tops and bottoms of cans shall not be coated.

b. <u>MIL-H-46004</u>. <u>Hydraulic Fluid</u>, <u>Petroleum Base</u>, <u>Missile</u>. Containers of one-gallon or less shall be coated YELLOW, a color approximating Color No. 23538 or 13538, containers larger than one-gallon shall be coated OLIVE DRAB, a color approximating Color No. 24064 or 24087. Exterior tops and bottoms of cans shall not be coated. TECHNICAL LIBRARY ABBOTTAEROSPACE.COM

c. <u>MIL-H-83282</u>. <u>Hydraulic Fluid</u>, Fire Resistant Synthetic Hydrocarbon Base, Aircraft. Containers of one-gallon or less shall be coated RED, a color approximating Color No. 11105 or 21105; containers larger than one-gallon shall be coated OLIVE DRAB, approximating Color No. 24064 or 24087. Exterior tops and bottoms of cans shall not be coated.

d. <u>MIL-H-6083</u>. <u>Hydraulic Fluid</u>, <u>Petroleum Base</u>, for <u>Preservation and</u> <u>Operation</u>. Containers of one-gallon or less shall be coated RED, a color approximating Color No. 11105 or 21105; containers larger than one-gallon shall be coated OLIVE DRAB, approximating Color No. 24064 or 24087. In addition, 5-gallon pails and 55-gallon drums shall have a WHITE band approximately oneinch wide painted on the side directly below the top head chime. Exterior tops and bottoms of cans shall not be coated.

e. <u>MIL-H-46170.</u> Hydraulic Fluid, Rust Inhibited, Fire Resistant Synethetic Hydrocarbon Base. Containers shall be coated OLIVE DRAB, approximating Color No. 24064 or 24087. Exterior tops and bottoms of cans shall not be coated.

5.9.3 Synthetic Lubricating Oils

a. <u>MIL-L-7808</u>. Lubricating Oil, Aircraft Turbine Engines, Synthetic Base. Exterior tops, bodies and bottoms of 8-ounce, 1-quart and 1-gallon containers shall not be coated.

b. MIL-C-8188. Corrosion Preventive, Aircraft Engine, Turbine. Exterior tops, bodies and bottoms of 1-quart and 1-gallon containers shall not be coated.

c. <u>MIL-L-23699</u>. Lubricating Oil, Aircraft and Turboprop and Turboshaft Engines, Synthetic Base. Exterior tops and bottoms of 8-ounce, 1-quart, and 1-gallon cans shall not be coated. The bodies shall be GREEN approximating No. 14110 of Federal Standard 595, and the markings shall be YELLOW, approximating No. 13655.

5.9.4 Petroleum Lubricating Oils.

a. <u>MIL-L-6081</u>. <u>Lubricating</u> Oil, Jet Engine. Exterior tops and bottoms of l-quart and l-gallon hermetically sealed containers shall not be coated.

5.9.5 Brake Fluids.

a. <u>VV-B-680</u>. Brake Fluid, Automotive. Exterior tops and bottoms of l-pint and l-gallon containers shall not be coated.

b. MIL-B-46176. Brake Fluid, Silicone, Automotive All Weather, Operational and Preservative. Exterior tops and bottoms of 1-pint and 1-gallon containers shall not be coated.

## 5.10 Marking.

5.10.1 <u>Materials and Methods</u>. Marking shall be clear, legible, durable and nonfading. Marking of unit packs, intermediate packs and exterior packs shall be accomplished by use of labels, stamping, stenciling, printing, lithographing, silk-screening, photo marking, embossing or other similar processes.

5.10.1.1 <u>Labels</u>. Labels may be used for address markings (see 5.10.4.6.19). They are permitted for contract data, and will be used when required by regulation or statute. Labels are permitted for marking identification data on unit containers, unit packs, intermediate packs and on exterior packs when the type or size of exterior pack does not permit stenciling, or the quantity procured does not permit printing.

5.10.2 <u>Color of markings</u>. For levels B and C, markings on OLIVE DRAB coated containers will be YELLOW. Markings on uncoated containers, such as fiberboard or plastic, and on containers coated other than OLIVE DRAB, shall be of contrasting color.

5.10.3 <u>Abbreviations</u>. The following abbreviations are authorized for use. In addition, abbreviations of the item descriptions will be permitted when approved by the procuring agency. Periods will not be used with abbreviations.

5.10.4 Identification, contract data and address markings.

5.10.4.1 Unit containers one gallon size and smaller. Identification and contract data shall be marked on unit containers one gallon size and less as specified in Table IV. (See Figure 1.)

5.10.4.2 Unit and intermediate containers. Identification and contract data shall be marked on unit and intermediate containers (folding, setup and fiberboard boxes) as specified in Table IVa. (See Figure 2.)

5.10.4.3 <u>Drums and pails</u>. Identification, contract data and address markings shall be marked on drums and pails as specified in Table IVb. (See Figures 3 and 4.) When shipments are palletized, address markings are not required on each individual container. (See 5.10.4.5.)

 $5 \pm 10.4.4$  Fiberboard shipping containers. Identification, contract data and address markings shall be marked on exterior fiberboard boxes as specified in Table IVc. (See Figure 5.) When shipments are palletized, address markings are not required on each individual container. (See 5.10.4.5)

5.10.4.5 Unit loads. Individual shipping containers composing a unit load shall be marked with the identification markings and contract data required. The palletized load shall be built on the pallet so that the markings on the individual containers show on two adjacent sides of the unit load. The gross weight and cube shall include the weight and cube of the pallet and shall be marked on the address label. Providing that a smooth surface is available, the shipment address shall be applied to the wider side of the palletized load.



If the palletized load does not provide a smooth surface (e.g., a pallet of 5-gallon cans), apply the label on a fiberboard panel, or on a tag placed on any suitable space of an identification marked surface of the load. (See Figure 6.)

5.10.4.6 Location and sequence of marking elements. The sequence and location of marking elements as shown in the Figures and Tables are desirable but the sequence of data and location may be varied as required by size of marking and container size and shape. Only the applicable information shall be marked on the containers, not the words in the Tables, such as "Code" or "Military Symbol". Containers not specified in this standard shall be marked to conform to the Tables as closely as practicable. Markings on containers of 5-gallon capacity or less shall occupy a minimum of 60% of the available vertical space on the sides to be marked.

5.10.4.6.1 <u>NATO Code</u>. The NATO Code number is an identifying designation consisting of a letter and a number assigned to a petroleum product standardized for use by the NATO Armed Forces. The NATO Code number shall be placed above the Military-Symbol and enclosed in a rectangle which may be either a continuous or broken line.

5.10.4.6.2 <u>Military Symbol</u>. The Military Symbol shall be the identifying designation assigned in a particular product specification.

5.10.4.6.3 Item description. The item description shall be the exact name and description of the item as it appears in the contract.

5.10.4.6.4 Specification number. The specification number shall be that shown by the contract or order and shall include the revision and amendment designation if any. Nonspecification products such as "brand name or equal" shall be identified with the appropriate brand name and part number as cited in the contract.

5.10.4.6.5 <u>Type, class and grade</u>. The applicable type, class and grade of product as designated in the product specification shall be shown. Type, class and grade may be omitted from markings when they are the same as the Military Sumbol.

5.10.4.6.6 National Stock Number. The stock number shall be the exact National Stock Number (NSN) consisting of 13 digits (9150-00-000-0000). When no NSN stock number is available, the applicable Federal Supply Classification (FSC), if known, shall be shown. In addition, when no NSN is available, the manufacturer's part number (MFR/PN) shall be used ans space shall be left blank immediately above the number for subsequent placement of the NSN. When the MFR/PN is used, the Federal Supply Code for Manufacturers (FSCM) appropriate to the part number shall precede the part number of the same line. The letters FSCM shall be used to identify the code indicated. (The FSCM is cross-referenced to manufacturers' names and addresses in Cataloging Handbooks H4-1 and H4-2.)



5.10.4.6.7 <u>Shelf-life markings</u>. There are two types of shelf-life items (see 3.6) and when specified in the contract, the type of shelf-life item shall be marked below the item identification data on exterior packs (fiberboard shipping boxes, drums and pails).

a. Marking for Type I shelf-life items shall be as follows:

Instructions:

For the Date of Manufacture, show the actual date, month and year.

For the Expiration Date, show the month of manufacture plus the number of months shelf-life assigned in contract or order.

b. Marking for Type II shelf-life items shall be as follows:

Instructions:

For the Date of Manufacture, show the date of manufacture or the middle month of quarter in which material is manufactured.

For the Test Date, show the date of manufacture plus the number of months shelf-life assigned in the contract or order.

After the New Test Date, leave a blank.

5.10.4.6.8 Date of Manufacture. When shelf-life marking is not required the date of manufacture of contents shall be designated by the center month of each quarter and year (namely, February 1985, May 1985, August 1985, and November 1985) in which most of the manufacturing is done, or the actual month and year manufacturing took place (e.g., January 1984, April 1984, December 1984). The date of manufacture may be indicated on the lids of Types I through V cans by embossing or other marking methods.

5.10.4.6.9 <u>Batch or lot number</u>. The batch or lot number shall be that series of numbers or letters or both established by the manufacturer to record production and control of product. Where both lot and batch numbers are applicable, both shall be shown. The word "BATCH" or "LOT" shall precede the applicable batch or lot number on all containers of all products. In those instances where the batch or lot number is manually stenciled on the side of the container, it will be applied in such a manner, utilizing good quality material, as to preclude any tendency to obliterate or smear. Batch or lot number may be indicated on the lids of Type I through V cans by embossing or other marking methods.



5.10.4.6.10 <u>Contract number</u>. The contract number assigned in the applicable procurement document shall be used.

5.10.4.6.11 Qualification number. The qualification number is the identification code assigned to a product which has been tested for compliance with the specification in advance of procurement. The qualification number for container marking purposes is that series of numbers or letters shown in the column "Test or qualification reference" of the applicable Qualified Products List (QPL). Examples: WORT-P97-3; and AML-AE-1234.5. If the QPL does not include a qualification number as defined above, the information listed under the column "Government designation" of the QPL shall be shown. The qualification number may be indicated on the lids of Types I through V cans by embossing or other marking methods. The abbreviation "QUAL" shall precede the applicable qualification number on all unit and shipping containers. When a contractor is repackaging and supplying a qualified product manufactured by another company, the name of the company to whom the qualification numbers were assigned shall prefix the qualification number on all unit containers. The qualification number shall appear on all unit containers of all products requiring qualification.

5.10.4.6.12 <u>Net weight</u>. Show the weight as the weight of the commodity alone in pounds, excluding any packaging material or container.

5.10.4.6.13 <u>Regulatory marking and labeling</u>. Hazardous materials shall be marked and labeled in accordance with the requirements of the 49 CFR, Parts 170-199, to satisfy all mode requirements enroute from source to destination.

5.10.4.6.13.1 <u>Proper shipping name</u>. The proper shipping name is the name of the hazardous material shown in Roman print in 49 CFR 172.101. The proper shipping shall be marked on the outside of each shipping container. The proper shipping name shall be distinct and apart from the item description.

5.10.4.6.14 Other precautionary and statute marking. Markings required for any purpose by statute or regulation shall neither obscure nor be obscured by other markings.

5.10.4.6.15 <u>Flash point and boiling point marking</u>. Unit and intermediate packs and shipping containers packed with flammable and combustible liquids with a flash point below  $200^{\circ}$ F (93.3°C) shall be marked with the flash point of contents. In addition, if the flash point is less than 73°F (22.8°C), the boiling point will also be marked. Flash point and boiling point markings shall be expressed in degrees Fahrenheit and shall be applied on the identification marked side by means of labeling, printing, stamping, or stenciling. Flash point shall be determined by using the appropriate test prescribed in 173.115(d) of 49 CFR.

5.10.4.6.16 Precautionary markings for hazardous chemicals and materials. All unit and intermediate packs of hazardous chemicals and materials shall be labeled in accordance with the applicable laws, statutes, regulations or ordinances, including Federal, State and municipal requirements. In addition, unit and intermediate including unit containers that serve as shipping containers such as pails and drums shall be marked with the applicable precautionary information in accordance with the American National Standard for Labeling of Hazardous Industrial Chemicals (ANSI 2129.1-1976). Markings shall be located as specified in Tables IV through IVc. When



container size and shape does not permit compliance with the prescribed location, markings shall be located on the opposite side of the unit container, shown in Figure 1. The letters in the signal words POISON, CAUTION and WARNING, and the text shall be large, legible, and appropriate to the space available.

5.10.4.6.17 Quantity. The number of units of issue in a unit pack, intermediate pack or shipping container shall be as specified.

5.10.4.6.18 Unit of issue. The unit of issue, unit of measure and quantity shall be as indicated in the contract or order. (See 5.10.3 for abbreviations.)

5.10.4.6.19 Address marking. Address markings specified in the contract shall be applied to shipping containers by means of labels or tags or as otherwise specified in 5.10.1.

5.10.4.6.19.1 Full carloads and full truckloads. The domestic address is not required on shipping containers and palletized unit loads shipped in full carloads or full truckloads to a single consignee.

5.10.4.6.19.2 Less than carload (LCL) and less than truckload (LTL). The domestic address is required on all shipping containers and palletized unit loads for less-than-carload and less-than-truckload lots. The domestic address is not required on shipping containers in a palletized unit load. One address marking will be applied to each unit load in an LCL or LTL shipment.

5.10.4.6.20 Gross weight. The gross weight shall be the combined weight of the item, cushioning materials and containers. The capital letters "WT" shall precede gross weight numerals. All weights shall be numerically indicated and shall be expressed in pounds to the next largest whole pound.

5.10.4.6.21 <u>Cube</u>. The letters "CU" shall precede the cube (cubic displacement) numerals. The cube shall be the cubic displacement of the shipping container, calculated from the extreme overall length, width, and height dimensions, and shall be shown in cubic feet expressed decimally to the nearest one-tenth of a cubic foot. Irregular, cylindrical, or round items shall be considered as rectangular solids.

5.10.4.6.22 <u>Contractor's name</u>. Where the contractor's name requires two or more lines, a readily identifiable abbreviation is permitted.

5.11 <u>Returnable Drum Deposit Marking</u>. Drums returnable to the supplier for a deposit refund shall be conspicuously marked to indicate the amount of deposit and the location to which it is returnable.

5.12 <u>Hazardous material data</u>. When specified in the contract, a Material Safety Data Sheet shall be prepared and submitted in accordance with Federal Standard No. 313.

Load is built on pallet so that the identification and contract data markings on individual containers show on two adjacent sides of the load.

If a smooth surface is available, the shipment address shall be applied to the wider side of the load.

If the load does not provide a smooth surface, the address may be applied on a fiberboard panel or on a tag placed on any suitable space on the wider side of the load.
